## WHARTON CENTER WIN A TRIP TO NYC SWEEPSTAKES

Please read these rules before entering the Sweepstakes. By entering and participating in the Sweepstakes, Entrant agrees to be bound by these Official Rules and represents that Entrant satisfies all of the eligibility requirements set forth below.

All entries must be received by Sponsor during the Sweepstakes Period. Entries submitted or completed by anyone other than the Entrant are void. No mechanical reproductions or automated entries will be accepted.
